- PA System Update
  - i. Taylor had Boist Systems come out and take a look at the system. They quoted us \$7000.00 for all new system/speakers/labor. Taylor did not ask about non-profit discounts. This was for a top of the line system that we could turn off certain speakers. Radio, Bluetooth...you don't have to turn off the music to talk it will automatically cut the music to hear the mic. They will adjust the speakers and set everything up for us. No worry about batteries for the mic as the batteries plug into the system. We would like to table until next time...would like Taylor to get us a good/better/best quote for us so we can decide what system we want to go through.
- Grounds Update for mowing
  - i. Grounds look amazing, it was a learning curve for them to figure out what all we wanted done. Laurie would like to propose we offer a flat \$200.00 to add in dragging all 3 arena areas. Kami makes a motion we ask Marcos to do the dragging addition, Sam 2nd the motion. Motion carried.

- We talked to the neighbor on Sunday because we were going to be running close to our turn off time and wanted to let them know we were running a little longer and just wanted to make sure they were ok with it. He said it was fine but was asking why we had a show this weekend due to the Youth Hunt weekend. We looked at our paperwork from 2011 (which is the most recent paperwork we have) and it says nothing about us not showing during the Youth Hunt. But there is something stating we might have 3 Saturday's in September that might go longer due to the MIHA show and that we don't have a show on the last Sunday of September. We need to make sure that we don't plan a show for the last Sunday of the month of September.
- Roof for the cookshack...Lori is still trying to get her brother to contact her back about the repairs needed. We also needed to get the door repaired on the entry booth. Roof needs to be done before winter so we don't come back in the spring with a collapsed roof.
- Taylor has stepped down from her position as treasurer/and board member at the end of the year (Banquet). She is also going to step down from her show chair position for next year. She also is stepping down from judges. Kami asked Amanda if she could take that on and Amanda accepted. Taylor has said if Amanda needs any help than she would help out.
- Elizabeth D has offered to step up and help out with Show Chair for next year with the Casual Pleasure Series.
